

FELLOWS PROGRAM

The MTO Fellows Program is an important initiative designed to encourage, promote and support a community of individuals who contribute to the diversity of the legal profession. The program is intended for individuals seeking to start law school in Fall 2018. Apply today to join the 2017-2018 class of MTO Fellows.

The program has three goals: (i) to assist with law school applications and LSAT preparation, particularly for individuals from diverse and disadvantaged backgrounds; (ii) to provide programming designed to build a foundation of knowledge concerning admission to and success in law school; and (iii) to establish a strong and broad network of professionals, mentors and peers that can serve as resources throughout Fellows' careers. The MTO Fellows Program will include:

- A monthly Saturday meeting, hosted at Munger, Tolles & Olson's downtown Los Angeles office, that provides information and workshops on topics pertinent to the law school admissions process and success in law school.
- An intensive, customized LSAT preparation course taught by TestMasters exclusively for MTO Fellows that will run during the summer months leading up to the October 2017 LSAT exam. **Fellows are required to attend this class at a location in downtown Los Angeles.**
- Access to community events, including receptions near the beginning and end of the program held at the firm's office in downtown Los Angeles to bring together past and current Fellows, Munger Tolles attorneys and a broad network of partners from the Southern California legal community.

FELLOWS PROGRAM

The course will run for a full year starting in March 2017 and ending February 2018. This allows sufficient time to advise Fellows in completing their law school applications by November 1, 2017.

All sponsored activities take place in the greater Los Angeles/Orange County area. Applicants must be located in or near the Los Angeles/Orange County area from June 15, 2017 until February 15, 2018 in order to be admitted to this program.
